#### CITY OF MANCHESTER (MANCHESTER PRIDE EVENT 2018) TEMPORARY TRAFFIC REGULATION ORDER 2018

The Council of the City of Manchester (hereinafter referred to "the Council") in exercise of its powers conferred by section 16A of the Road Traffic Regulation Act 1984 ("The Act") as amended, and all other enabling powers, and with the consent of the Secretary of State, hereby makes the City of Manchester (Manchester Pride Event 2018) Temporary Traffic Regulation Order 2018 ("The Order"):-

- This Order shall come into operation on Friday 24<sup>th</sup> August 2018 and may be cited as the City of Manchester (Manchester Pride Event 2018) Temporary Traffic Regulation Order 2018. The Order will be operative until 24.00 hours on Monday 27<sup>th</sup> August 2018.
- 2. Save as provided in Articles 4 and 5 to this Order no person shall except upon the direction or with the permission of a police constable in uniform or a traffic warden, cause or permit any vehicle to enter, proceed, stop or wait in any street or length of street specified in Schedule 1 to this Order during the hours and days specified in Schedule 1 to this Order.
- 3. Save as provided in Article 5 to this Order no person shall except upon the direction or with the permission of a police constable in uniform or a traffic warden, cause or permit any vehicle to enter, proceed, stop or wait (including for the purpose of delivering or collecting goods or loading or unloading a vehicle) in any street or length of street specified in Schedules 3 and 4 to this Order and during the hours and days specified in Schedules 3 and 4 to this Order or until a time when normal operation can be resumed
- 4. The provisions of Articles 2 and 3 above shall not apply in respect of:
  - (a) emergency services vehicles being used in pursuance of statutory powers or duties;
  - (b) by Council officers acting in pursuance of statutory powers or duties;
  - (c) any vehicle used in conjunction with or for the purpose of Manchester Pride Event 2018.
  - (d) any person in possession of a valid official pass issued in respect of the Manchester Pride Event 2018.
  - (e) any person accessing premises situated on or adjacent to a road specified in Schedules 3 and 4 or any other premises accessible for pedestrians from, and only from such road.
- 5. Nothing in Article 2 to this Order shall prevent any vehicle from entering and proceeding or waiting in any street or length of street specified in Schedule 1 to this Order for so long as it is necessary to allow the vehicle to be used:
  - (a) to enable a bona fide cash collection to be made from any premises situated on or adjacent to the lengths of road specified in Schedule 1 to this Order where the collection is being made at the request of the occupier of such premises;
  - (b) between 08.00 hours and 11.00 hours to enable a bona fide delivery to be made to any premises situated on or adjacent to the lengths of road specified in Schedule 1 to this Order where such delivery is being made at the request of the occupier of such premises;
  - (c) by employees of the Royal Mail to make deliveries to premises situated on the lengths of road specified in Schedule 1 to this Order.
- 6. Nothing in Article 2 to this Order shall prevent:
  - (a) any bus requiring egress from Chorlton Street Bus Station from entering Sackville Street at its junction with Major Street so as to proceed in a north westerly direction towards its junction with Portland Street;
  - (b) a hackney carriage from entering, proceeding or waiting on Major Street between its junction with Chorlton Street and its junction with Minshull Street.
- 7. Save as provided in Article 8 to this Order no person shall except upon the direction or with the permission of a constable in uniform cause or permit any vehicle to proceed in the length of road specified in Column 1 of Schedule 2 to this Order in a direction other than that specified in relation to that length of road in Column 2 of Schedule 2 to this Order.

- 8. Nothing in Article 7 of this Order shall apply to the driving of any mechanical road cleansing vehicle being used in pursuance of statutory powers.
- 9. The alternative routes available;
  - (a) for use by vehicles are via:
    - (i) Portland Street; Princess Street; Whitworth Street and Aytoun Street;
    - (ii) Portland Street; Charlotte Street; Fountain Street; New York Street,
  - (c) for use by pedestrians are via: Portland Street; Princess Street; Whitworth Street and Minshull Street.
- 10. Save as provided in Article 11 to this Order no person shall cause or permit any vehicle proceeding in the road specified in Column 1 of Schedules 5 and 6 to this Order to make a right turn into the road specified in Column 2 of Schedules 5 and 6 to this Order.

#### **EXEMPTIONS**

- 11. Nothing in Article 10 of this Order shall apply to any vehicle used for fire brigade purposes or to an ambulance or a vehicle in the service of a police force or in any case being used in pursuance of statutory powers.
- 12. Any statutory provision referred to in subsections (10) and (11) of Section 16A of the Act currently in force which is affected by this Order shall take effect subject to this Order and shall, insofar as it is inconsistent with this Order be suspended for the duration of this Order, including but not limited to:

Portland Street	Bus gate from its junction with Minshull Street in a north easterly direction to its junction with Aytoun Street, and the north east bound lane from its junction with New York Street in a north easterly direction to the projected north eastern kerb line of Minshull Street

- 13. In this order:-
  - (1) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
  - (2) "Bus" shall have the same meaning as in Regulation 22 of the Traffic Signs Regulations and General Directions 2002

"Hackney Carriage" has the same meaning as in the Town Police Clauses Act 1847 and the Local Government (Miscellaneous Provisions) Act 1976.
